Parents seeking admission of their wards must register their ward's name online(offline) and submit duly filled registration form in the school office on the said date and time. Dates for the verifications will be allotted to each child at the time of submitting the duly completed registration form. On the allotted dates for verification, the parents will come with the child. If there are more number of candidates (more than the available seats) found eligible for admission after the verification, then the required number will be finalized by draw of lots. The list of the selected students will be displayed on the school notice board/website and their parents will be given time to deposit admission fee (+first quarter Composite Tuition Fee) and complete other formalities. Only the parent of the child and no other relatives will be able to complete the admission formalities.

If the parent, whose child's name is there in the admission list, is unable to complete the formalities within the given dates will forfeit the chance for the admission. Fee once paid at the time of admission is non-refundable in case of withdrawal. The management is not responsible for any unauthorized persons or activities in the name of the admission. Date of birth once registered cannot be altered. [(as per U.P.G.O. No.1101/1[(5)].

It must be very clear that the parents who are seeking admission of their wards are fully aware of all the above conditions and have already read these conditions which were displayed on the school notice board/website much in advance. The Management reserves the right to have the last word in all matters related to admission.

### Medium of Instruction

English is the primary medium if instruction in our school. However, Hindi is given equal importance as the local and national official language

#### Removal from school

A child's place in school is subject to good behaviour and satisfactory work. The school expects itspupils to be obedient and courteous not only in the school but outside as well. Any objectionable conduct reported either inside or outside the school, is part of the pupils, then liable for disciplinaryaction. Repeated misconduct, cheating in examination or other offenses against honesty or moralitywill lead to the expulsion of Pupil. Repeated misconduct and non-cooperation from the parent is also a ground for expulsion from the school:

Academic year is divided into Two Term. There will be two Unit Tests, Half yearly Exam (September), Annual Exam (March). All dates will be displayed in the school website much in advance.



#### Details of the fee structure

The details of fees for the previous year, current year and the ensuing year are given below. No child will be permitted to begin a new term unless all arrears due on his / her account have been cleared in full before the commencement of the new term. The fees will be deposited in the bank or school online payment portal only according to the dates mentioned in the fee book, failing to do so, the fine will be charged accordingly.

The fee will be collected in quarterly four instalments (UP self-financed school fixation act 2018, 3:3:a:(i)). You are requested to remit the fees before 10th of every quarter. Late fee charges will be applicable after the said date. Every pupil will pay fees of 12 months. School also provides the facility to deposit fees monthly, those who find difficult to pay quarterly. No reduction of fee is made on account of summer and winter holidays or other vacations or temporary absence. There will not be any rebate for anyone paying the whole year fee together.

Students / Parents have to pay the charges of optional facilities or they participate in any activity (Activity Charges).
